## CHANGE OF EDUCATION LEVEL

### ❑ Meeting your immigration requirements

- To maintain your F-1 visa status, you must do the following when you arrive for your new degree program:
  - ✓ Complete Immigration Document Check-In at the Office of International Programs
  - ✓ Attend CSU International Student Orientation
  - ✓ Be registered as a full-time student  
*Undergraduate = 12 credits per semester; Graduate and PhD = 9 credits per semester*

### ❑ Other considerations

- **Travel:** If you are traveling between programs, please be aware that once your new I-20 has been processed, you will need to use it to re-enter the United States. Plan ahead!
- Please note that some students travelling with a Change of Level I-20 have had a difficult time getting back into the United States because Customs and Border Protection was not able to see the new program in their database. When you are making your travel arrangement, make sure to give yourself sufficient time at the airport in case you are delayed going through customs, and carry the contact information of the Office of International Programs with you.
- **Visa status:** You will not need to apply for a new F-1 visa when requesting a change of level *unless your visa has already expired and you plan to travel outside of the United States*. Your current F-1 visa will remain valid until its expiration date.
- You will not need to pay the SEVIS fee again.
